

# Privacy Policy

## Arhat USRP

This Privacy Policy describes how Arhat USRP ('we,' 'us,' or 'our') collects, uses, and protects your personal information when you use our services, website, and applications. By using our services, you agree to the collection and use of information in accordance with this policy.

## 1. Information We Collect

### 1.1 Personal Information

We may collect the following types of personal information:

- Name, email address, and contact information

### 1.2 Usage Information

### 3. Information Sharing and Disclosure

- The purposes for which we process the information
- Legal and regulatory requirements
- Our legitimate business interests

When information is no longer needed, we will securely delete or anonymize it in accordance with applicable data protection laws.

## 7. International Data Transfers

Your information may be transferred to and processed in countries other than your country of residence. These countries may have different data protection laws. We ensure appropriate safeguards are in place to protect your information in accordance with this Privacy Policy and applicable laws.

## 8. Children's Privacy

Our services are not directed to individuals under the age of 18. We do not knowingly collect personal information from children. If you are a parent or guardian and believe your child has provided us with personal information, please contact us immediately, and we will take steps to delete such information.
